IT Security – what should you be worried about? Do you know about the EU’s new “General Data Protection Regulation”?

IT security and data protection are concerns that we all recognise – and stories of data leaks, e-mail hacking, and IT fraud all still seem to appear in our newspapers every day.

ABIAL warmly invites all its members – and guests – to an early evening of presentations on these topics.

IT Security – what should you be worried about?

Vincent Villers, PwC Luxembourg’s lead partner advising on IT security matters, will warn us about some of the current threats. He will focus on two topics.

Firstly, what should **you** as a company employee be being careful about? What are the scams and frauds out there that you should be most worried about? And how secure are your e-mails and data, in a world of free wi-fi everywhere, “bring your own device”, and working from home or hotel room. Your company may be trying hard to protect its network, but could you – quite inadvertently – be the cause of weaknesses or threats? During the evening, there will be a live demonstration of some of the risks to which participants are potentially exposed.

Secondly, are there questions that **non-executive directors** should be asking around the board table? Should the company just trust the IT department to keep everyone safe? Or are there hard questions that need to be asked?

Do you know about the EU’s new “General Data Protection Regulation”?

Frédéric Vonner, a PwC Luxembourg partner, is a specialist adviser on data protection law and practice, an area where regulation is growing and tightening.

In 2016, the European Parliament approved the General Data Protection Regulation (“GDPR”), unifying data protection law across the EU Member State, and which will replace the current EU Data Directive. Although the GDPR will not go into effect until May 2018, there are many new and significantly enhanced requirements that companies need to take action on, during the year running up to this deadline. What should you know about this topic?

Both our speakers are experts in their field, and there will be time after each of their talks for you to ask questions.
